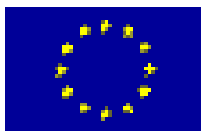

SPAS is an initiative promoted by a consortium of 13 organisations coming from 9 different European countries, and supported by the European Commission within the 6<sup>th</sup> Framework Programme (FP6).

The SPAS Project will create a pool of enterprises of the agro-food sector in order to promote technological cooperation among companies, and support research and innovation activities.

The aim of SPAS is to encourage small and medium-sized enterprises (SMEs) to take part in the 6<sup>th</sup> and 7<sup>th</sup> Framework Programmes through new instruments like Integrated Projects (IP) and Networks of Excellence (NoE). The participation will be focused on new and on-going projects, paying particular attention to calls for proposals and calls for tenders.

### 7<sup>o</sup> FRAMEWORK PROGRAMME (7FP) WAS LAUNCHED BY THE EUROPEAN COMMISSION!!!

The EU's largest ever funding programme for research and technological development, the Seventh Framework Programme (FP7), was launched on 1 January. The FP7 run for the period 2007 to 2013, and the FP7 for nuclear research activities (Euratom) for 2007 to 2011.

With a total budget of €50.521 billion, FP7 will run for ~~of~~ seven years. An additional €2.7 billion has been earmarked for the Euratom programme on nuclear research, which will run for five years. In real terms, there are 40 per cent more funds on average per year.

The proposal provides new impetus to increase Europe's growth and competitiveness, recognising that knowledge is Europe's greatest resource. The programme places greater emphasis than in the past on research that is relevant to the needs of European industry, to help it compete internationally, and develop its role as a world leader in certain sectors. ## HOW IS 7<sup>th</sup> FRAMEWORK PROGRAMME (FP7) STRUCTURED?

The European Community part of FP7 is organised in four programmes corresponding to four basic components of European research:

- **Cooperation**

Support will be given to the whole range of research activities carried out in trans-national cooperation, from collaborative projects and networks to the coordination of national research programmes. International cooperation between the EU and third countries is an integral part of this action.

This action is industry-driven and organised in four sub-programmes:

- **Collaborative research** will constitute the bulk and the core of EU research funding
- **Joint Technology Initiatives** will mainly be created on the basis of the work undertaken by the European Technology Platforms
- **Coordination of non-Community research programmes**
- **International Cooperation**

- **Ideas**

This programme will enhance the dynamism, creativity and excellence of European research at the frontier of knowledge in all scientific and technological fields, including engineering, socio-economic sciences and the humanities. This action will be overseen by a European Research Council

- **People**

Quantitative and qualitative strengthening of human resources in research and technology in Europe by putting into place a coherent set of **Marie Curie actions**.

- **Capacities**

The objective of this action is to support research infrastructures, research for the benefit of SMEs and the research potential of European regions (Regions of Knowledge) as well as to stimulate the realisation of the full research potential (Convergence Regions) of the enlarged Union and build an effective and democratic European Knowledge society.

## EUROPEAN TECHNOLOGY PLATFORM FOR GLOBAL ANIMAL HEALTH - VISION 2015

A "European Technology Platform for Global Animal Health" was launched on 16 December 2004 in Brussels. The platform led by industry brings together the veterinary pharmaceutical industry, biotechnology companies, livestock producers, research institutions, universities, regulatory authorities and the financial world. It is supported by Development Commissioner Louis Michel, Science and Research Commissioner Janez Potocnik and Health and Consumer Protection Commissioner Markos Kyprianou. The initiative is being set up to deliver new or improved tools, in particular vaccines and diagnostics, for the control and prevention of major animal diseases both in the developing world and in Europe.

The aim of the Technology Platform is: To facilitate and accelerate the development and distribution of the most effective tools for controlling animal diseases of major importance to Europe and the rest of the world, thereby improving human and animal health, food safety and quality, animal welfare, and market access, contributing to achieving the Millennium Development Goals.
